

Preparing for the UN High-Level Meeting on NCDs: What you need to know

The UN High-Level Meeting on NCDs is a unique opportunity for governments to showcase how they have progressed on NCDs and the time to take bold political commitments towards addressing the NCD epidemic. Negotiations on the modalities resolution to agree on the overall format and scope of the meeting began at the UN in March. Here is a list of actions that NCD alliances can take:

Alert your key government contacts of the HLM opportunity

Take the time to meet face to face with your government contacts - your ministries of health and other ministries such as finance or foreign affairs - to make sure they are aware of the meeting taking place this year and share [campaign priorities](#) [1] with them. Negotiations on the content (outcome document) of the meeting aren't expected until May. This means you should be taking the time now to raise awareness of the meeting and cultivating relationships, before advocacy efforts ramp up during the negotiations on the meeting's outcomes.

Urge your Head of State or Government to attend the HLM

NCDs are not an issue confined to the health sector and require the highest level of political attention. One of the key priorities for the HLM is ensuring that Heads of State and Government attend. Voluntary National Reviews and Regional Preparation Meetings for the High Level Political Forum

The [High Level Political Forum](#) [10], which is the main platform for follow-up and review of the Sustainable Development Goals, will take place 9-18 of July this year, covering Goals 6, 7, 11, 12, 15 of the SDG agenda, presenting several overlaps with NCD-related priorities. The ministerial segment will take place 16-18 July.

[48 countries](#) [11] have indicated that they will be presenting [Voluntary National Reviews](#) [12] to share experiences, including successes, challenges and lessons learned, with a view to accelerating the implementation of the 2030 Agenda. If your country is listed, we would encourage you to get involved with the process and investigate how you can take part and advance NCDs in the discussions. Another way to get involved would be by participating in one of the four upcoming [Regional Preparatory Meetings](#) [14] taking place over the coming weeks. While specific opportunities for civil society engagement may differ from region to region, we would strongly recommend looking into potential avenues for getting involved.
