Dear Colleagues,

The second Global NCD Alliance Forum is taking place at a crucial moment. The NCD epidemic is a priority health and development issue – 70% of all mortality in 2015 was due to NCDs, with the majority of these deaths occurring in low- and middle-income countries. As exposure to NCD risk factors increases due to global trends such as rising inequalities, urbanisation, and ageing, the urgency for action is clear. We must address NCDs if we are to achieve the Sustainable Development Goals and ensure health and wellbeing for all.

The third United Nations High-level Meeting on NCDs will be held in New York in 2018, where governments will come together to take stock of progress and renew commitment to accelerate action on NCDs. The 2018 High-level Meeting is a significant opportunity to generate political leadership for NCDs and tackle the bottlenecks and barriers that continue to hinder the NCD response.

To capitalise on this important moment in the global NCD response, the Global NCD Alliance Forum is organised under the banner theme of "Stepping up the pace on NCDs: making 2018 count." Over the course of the Forum, a mixture of plenary sessions and workshops will focus on three key areas:

1. Advocating for NCD prevention and control

Friends of Cancer Patients



Friends of Cancer Patients (FoCP) charity is a non-profit organisation registered at the UAE Ministry of Social Affairs. FoCP was founded in September 1999 under the directives and patronage of Her Highness Sheikha Jawaher bint Mohammed Al Qasimi, Wife of the Ruler of Sharjah, Founder and Patron of FoCP, International Ambassador of the World Cancer Declaration for Union for International Cancer Control and International Ambassador for Childhood Cancer for UICC. As part of her commitment to the fight against cancer and NCDs, Her Highness Sheikha Jawaher Bint Mohammed Al Qasimi is the Patron of the Global NCD Alliance Forum 2017.

FoCP is committed to helping cancer patients and their families get through the long and arduous journey of cancer treatment. Since its inception, FoCP has delivered moral and financial support to over 1,300 patients and their families, irrespective of their nationality, gender, age, religion or ethnicity. FoCP provides a broad spectrum of financial and emotional support, with a special focus on cancer survivorship.

Awareness is at the heart of FoCP's mission, which involves creating awareness around the early detectable cancers; namely, Breast Cancer, Cervical Cancer, Prostate Cancer, Testicular Cancer, Colorectal Cancer, Skin Cancer and Childhood Cancer under the umbrella of 'KASHF' for early detection. In this regard, FoCP has launched numerous cancer focused awareness initiatives with a regional and international target scope, including Pink Caravan for breast cancer, Ana for childhood cancer, Shanab for male cancer, and Mole Talk for skin cancer, all of which aim to benchmark best practices.

With a dynamic team that embraces hundreds of volunteers from all walks of life, FoCP embraces multisectoral collaborations to realise its mission. FoCP is a member of different international and regional organisations including, the Union for International Cancer Control (UICC) based in Geneva Switzerland, American Cancer Society, and the Kuwait-based Gulf Federation for Cancer Control.

The NCD Alliance



The NCD Alliance is a unique civil society network, uniting 2,000 organisations in more than 170 countries, dedicated to improving NCD prevention and control worldwide. It was founded in 2009 by three global federations: the International Diabetes Federation (IDF), the World Heart Federation (WHF), and the Union for International Cancer Control (UICC), which were joined the following year by the International Union Against Tuberculosis and Lung Disease.

Together, these organisations represented the four main non-communicable diseases (NCDs) outlined in the World Health Organization's (WHO) 2008-2013 Action Plan for NCDs: cardiovascular diseases, diabetes, cancer, and chronic respiratory diseases. They came together in recognition that these conditions share common risk factors (including tobacco use, physical inactivity, harmful use of alcohol and unhealthy diets), and share common solutions. By working together as an alliance, they created a mutual platform for collaboration and joint advocacy. The mantra of NCD Alliance has always been 'together we are stronger'.

Acknowledging the complexity of the challenge and the acceptance of a broader definition of NCDs beyond the '4 x 4' approach, three new federations/organisations joined NCD Alliance in 2014: the Framework Convention Alliance (FCA), Alzheimer's Disease International (ADI) and Management Sciences for Health (MSH). These organisations bring important perspectives and competence on tobacco control, mental/ neurological health and health systems to NCD Alliance's work.

Today, our network of 2,000 organisations includes over 1,000 member associations of our federations, joined with 1,000 global and national civil society organisations (CSOs), scientific and professional associations, academic and research institutions, and dedicated individuals. Together with strategic partners, including the WHO, the United Nations (UN) and governments, the NCD Alliance works at global, regional and national levels, to bring a united civil society voice to the global campaign on NCDs.

The NCD Alliance is guided by our Strategic Plan 2016-2020. Our work is based around four strategic pillars to drive progress towards the globally agreed goal of a 25% reduction in premature NCD mortality by 2025:

- Advocacy: Lead global advocacy to fulfil political commitments on NCD prevention and control
- **Accountability**: Promote accountability for commitments, resources, and results in NCD prevention and control.
- **Capacity Development:** Strengthen the capacity of NCD civil society organisations and alliances at national and regional levels.
- Knowledge exchange: Broker knowledge on evidence-based NCD policy and practice.

Overview of the Global NCD Alliance Forum

The second Global NCD Alliance Forum provides a prime opportunity to unite and mobilise NCD civil society ahead of the 2018 UN High-level Meeting on NCDs (UN HLM).

The Forum will bring together representatives from NCD civil society from across the world, building links with multilaterals, international NGOs, select government representatives, and NCD experts. It will be an interactive forum, providing a safe space for knowledge exchange, sharing good practice, and capacity building for NCD advocacy.

The Forum is timed to allow for advocacy planning towards the 2018 UN HLM on NCDs. It will homogenise knowledge regarding advocacy opportunities and will catalyse advocacy efforts of the NCD community.

The Forum will launch the Advocacy Agenda of People Living with NCDs and will highlight good practice in engaging people living with NCDs, and youth, as champions of the movement.

The Forum is organised under the banner theme of "*Stepping up the pace on NCDs: making 2018 count*" with a view of facilitating advocacy planning for the 2018 UN HLM on NCDs. It will focus on three key areas:

- Advocating for NCD prevention and control
- Breaking down silos and building synergies in the SDG era
- Sharing tools and strategies for NCD advocacy and mobilisation

FORUM OBJECTIVES

- To further the Sharjah Declaration by facilitating advocacy campaign planning towards the 2018 UN HLM
- To convene the civil society network of national/regional NCD alliances to share experiences and lessons learnt and connect with key stakeholders across sustainable development;
- To promote the engagement of people living with NCDs and youth in the NCD movement, including through launching the Advocacy Agenda of People Living with NCDs;
- To strengthen the capacity of the network of national/regional NCD alliances, including in ar-eas such as coalition building, sustainability and issue specific advocacy;
- To build consensus on advocacy priorities for 2018 UN HLM on NCDs.

	Civil society organizations have a critical role in advocating for the allocation of resources to NCD programming and holding governments accountable for their commitments to NCD prevention and control. Both require a level of financial and economic literacy, specifically the ability to understand and effectively communicate financial and economic information. In advocating for increased resource allocation during participatory budget and planning processes, civil society organizations/ alliances must understand and communicate the value of cost effectiveness and other economic data. Effectively delivering this message requires that advocates communicate in a manner that resonates not only with decision-makers in national and sub-national health departments but also those within the finance department.	

	Once commitments have been made, advocates must then have the capacity to use resource tracking and budget data to hold the government accountable. This workshop delves into the urgent need for elevating the issue on NCD financing among decision-makers and closing the resource gap for NCDs.

Airport Transfers

All delegates are asked to take a taxi to their allocated hotel upon arrival at the airport (see below for address details). About Sharjah

Location

Stretching from the Arabian Gulf to the Gulf of Oman, Sharjah is the third largest of the seven Emirates which form the United Arab Emirates.

Rich in history and culture; a land with a wealth of values, warm and friendly people, all year-round sunshine and distinctive blend of glorious past and bright present, the emirate is an attractive and safe destination offering the right ingredients for leisure and business alike. Having been crowned the "Cultural Capital of the Arab World" in 1998, the Islamic Culture Capital for 2014 and the Arab Tourism Capital for 2015, the smiling emirate of Sharjah has for generations, been welcoming visitors from around the world.

Sharjah is the oldest Emirate on the coast of Oman, and lies in the centre of other emirates, spread over an area of 2600 sq. km, occupying 3.3% of the total area of the United Arab Emirates (not counting the islands). It is the only emirate that overlooks the coastline on the Arabian Gulf from the West and the Gulf of Oman (Indian Ocean) from the East. The coastline on the Gulf extends about 20 km, and within 80 km to the Gulf of Oman.

The history of the population dates back to 6000 years ago, when the place was called by the name of "Sarqua" and the people were generally engaged in maritime trade, in addition to agriculture, fishing and pearl diving. Most of the habitation was around the valleys.

Weather

The weather is pleasant from the month of November to April, with the days being sunny and warm and evenings cool, with low humidity and daytime temperatures ranging from 18 degrees Celsius to 30 degrees Celsius. Rains and tropical storms can be expected during January, February and March. The weather gets warm from May to September, with extremely high temperatures at noon in July and August up to 45 degrees Celsius.

Things to do

Sharjah has a lot to offer to tourists and has a number of famous attractions including museums, traditional Souks, modern shopping malls and family entertainment to keep visitors of all ages busy. Your stay in Sharjah is sure to be an unforgettable experience!


Shopping




Things to remember


